Sub: Mandatory Requirement of Students' Aadhaar and Aadhaar-seeded bank account for availing Mukhya Mantrir Nijut Moina Aasoni, Mukhya Mantrir Nijut Babu Aasoni, and Fee Waiver Scheme.

Sir/ Madam,

With reference to the subject cited above, I have the honour to inform you that, in pursuance of the Executive Order No. 163553/I/1585164/2026 dated 4th June, 2026, issued by the Finance Department, Government of Assam on the subject 'Adoption of Aadhaar-based DBT Framework and mandatory on-boarding of State-funded Beneficiary-oriented Schemes in DIDS', all State-funded beneficiary-oriented schemes are required to be onboarded onto the Aadhaar-based Direct Benefit Transfer (DBT) framework. In case of MMNMA and MMNBA, all DBT will be done only through Aadhaar-based payment system to the Aadhaar-seeded bank accounts of eligible beneficiaries.

Accordingly, all Higher Educational Institutions should ensure the following:

1. Ensure all students eligible for Mukhya Mantrir Nijut Moina Aasoni, Mukhya Mantrir Nijut Babu Aasoni, and Fee Waiver Scheme have valid Aadhaar.
2. Ensure that the bank accounts of all eligible students are seeded with their Aadhaar.
3. Ensure that there is no mismatch between the names of the beneficiary as registered in SAMARTH and Aadhaar. In case there is any discrepancy of the names of the eligible students in SAMARTH and the name as mentioned in their Aadhaar, then such discrepancies should be corrected
4. Ensure that the Aadhaar linked phone number of beneficiaries are active for OTP based verification. In case the Aadhaar linked phone number is inactive or incorrect then such eligible students must update or correct the Aadhaar linked phone number.
5. In cases where a student does not possess valid Aadhaar, the concerned HEI shall encourage all such students to enrol for Aadhaar.
6. Ensure wide publicity of the above instructions among all students through appropriate communication channels so that every eligible student is informed of the mandatory Aadhaar-related requirements for availing benefits under the aforesaid schemes.

This is for favour of your kind information and necessary action.
